Declaration of compliance 20-2016

Subject: paper sacks

Stora Enso Poland S.A. declares that paper sacks produced by Stora Enso are compliant with the applicable laws, namely:

1. Regulation (EC) of the European Parliament and of the Council No 1935/2004 of 27 October 2004 on materials and articles intended to come into contact with food.
2. Commission Regulation (EC) No 2023/2006 of 22 December 2006 on good manufacturing practice for materials and articles intended to come into contact with food
3. Regulation (EC) of the European Parliament and of the Council No 178/2002 of 28 January 2002 laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety
4. Regulation (EC) of the European Parliament and of the Council No 852/2004 of 29 April 2004 on the hygiene of foodstuffs
5. Health Minister regulation of 15 January 2008 on list of substances whose usage is permissible in the process of production. Products, articles where the substances are used are non – artificial and are intended to come into contact with food (Dz. U. Nr 17, poz.113).
6. The food and nourishment safety act of 25 August 2006 (Dz.U. No. 171, poz.1225) and later changes
7. Commission Regulation (EC) No 2023/2006 of 22 December 2006 on the restriction of use of certain epoxy derivatives in materials and articles intended to come into contact with food
8. Commission Regulation (EC) No 10/2011 of 14 January 2011 on plastic materials and articles intended to come into contact with food
9. European Parliament and Council Directive 94/62/EC of 20 December 1994 on packaging and packaging waste

Stora Enso Poland S.A. declares that above mentioned paper sacks are suitable for contact with dry and loose foodstuff, fruits and vegetables. To ensure the safety of the paper sack conditions mentioned below have to be met:

- Protection against moisture and soaking when transporting, filling the paper sack with a product, storing (empty as well as filled paper sacks).
- Ensuring that the paper sacks are stored in a dry and airy warehouse. The foil protection should be removed as soon as the paper sacks have been transported to a warehouse.

Moreover we declare that Stora Enso Poland S.A. has an Integrated Management System of safety, quality and environment (ISO 9001:2008, ISO 14001:2004, OHSAS 18001:2007 compliant) and our production process in which paper sacks are manufactured is organized in compliance with the requirements of GMP and GHP .
